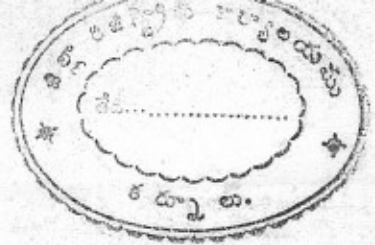

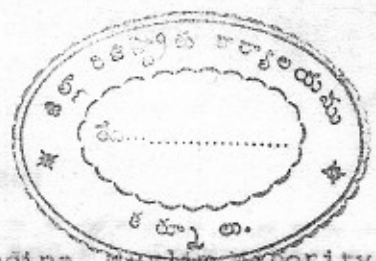

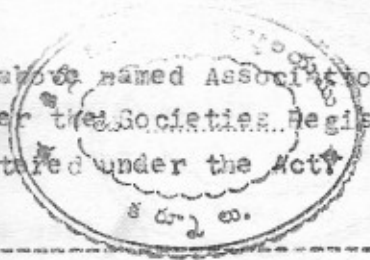

RULES AND REGULATIONS OF THE MADINA MUSLIM MINORITY WELFARE AND EDUCATIONAL SOCIETY, BRAHMANAKOTKUR, KURNOOL.

1. Name: This Association shall be call as MADINA MUSLIM MINORITY WELFARE AND EDUCATIONAL SOCIETY, Brahmanakotkur, Kurnool District.
2. Address: Brahmanakotkur, Kurnool District, A.P.
3. Management: The present management body shall consists of a president, vice president, Secretary and joint secretary, and treasurer with executive committee members.
4. Membership:- The Association shall consists of

1)) Ordinary Members, 2) Life Members.

1) The ordinary membership can be obtained by paying Rs.50/- per year. The members shall be an old student during the tenure of 1959-60 to 1969-70 (one decade) of MADINA MUSLIM MINORITY WELFARE AND EDUCATIONAL SOCIETY, Brahmanakotkur, Kurnool District. The applicant for enrolment as a member shall be filled Bio-data in the proforma given by the Association.

2) Life membership can be obtained by paying Rs.500/- or above at a time.

Being a member/Life member of the association, shall donate amounts to strengthen the Association financially for social activities.

5. Removal and disqualification of members.

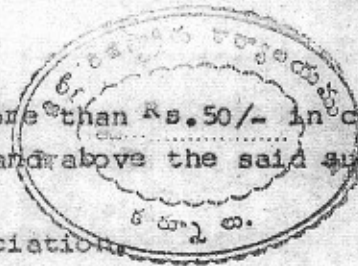
A member who is in arrear on account of nonpayment of yearly subscription of Rs.50/- by the commencement of the year i.e., before 1st October of every year, shall be deemed to be a defaultuer and shall be disqualified from exercising his vote at any meeting which will be held on 6th October of the every year.

Any member can be expelled for his misconduct, indiscipline and anti-social activities, on the recommendation of the office bearers and Executive Committee members, by a Majority Decision.

6. Re-Instatement of Members :

The office bearers and the executive committee members may re-instate a member who has been struck off from the rolls of the membership for non-payment of any arrears due by him on his paying the arrears amount together with entrance fee. A member who has resigned this membership of the Association may be re-instated by the office bearers and the executive committee members as a New members.

13. Treasurer :- He shall not have more than Rs. 50/- in cash on hand and shall remit all sums over and above the said sums of Rs. 50/- into the Bank.

- A). He shall be custodian of the association.
- B). He shall collect the membership and donations Etc., pertaining to the association.
- C). He shall jointly operate the Bank Account of the Association with the president or secretary.
- D). He shall make all payments authorised by the Executive Committee and maintain a clean account.
- E). He shall issue Receipts for the Subscription and donations and Etc., and maintain the cash.
- F). He shall submit the account of Receipts and Payment to the Executive Committee.

14. General Body Meeting :

The Quorum for the meeting shall be one-third of members enrolled. There shall be a meeting of General Body on 6th October each year, the election of Office Bearers and members of the Executive Committee and for reviewing the work done in the previous year and for passing the Accounts, and the budget and for concerting members of the promotion of the object of the Association. (Ten clear days notice shall be given in case of all General Body Meeting).

15. Special Meeting of the General Body :

A special meetings of the General Body shall be covered by the Secretary on a requisition signed by not less than 2/3 (three-fifths) of the members on the rolls and specifying the purpose for which the meeting is required to be held.

16. Power to make Laws:

The Executive Body reserves to itself the right to make or amend by laws as and when required for the management of the Association after approval by the General Body.

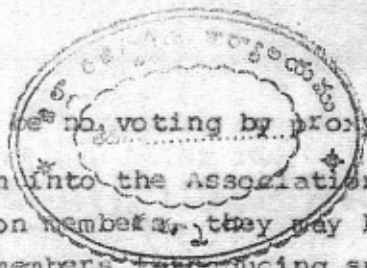
17. Managing Committee Meeting:

Ordinary three days notice shall be given for the meetings the Office bearers and the Executive Committee members. But in urgent cases 24 hours notice shall be sufficient. The Secretary shall be power to obtain resolution of the office bearers and the executive committee members by circulation. The said committee shall not atleast once in three months.

18. Quorams:

The Quorum for the E.C. Meetings shall be 1/3rd members of the Executive Body.

19. Voting By Proxy : There shall be no voting by proxy
20. Strangers will have no admission into the Association but to being introduced by the Association members, they may be admitted on payment of Rs. 10/- and members introducing such strangers shall hold themselves responsible for all conduct behavoured damages caused by them and other losses.
21. A Banking account shall be opened for the Association in the name of the President|Secretary and Treasurer and any two will have power to operate on this account.
22. The Association as a body shall not take part in politics.
23. No member shall have a right to proceed to a court of law with regard to affairs of the Association.
24. FUNDS: Funds of the Association only for the attainment of the objectives of the Association.
25. AMENDMENTS: No amendment or alteration shall be made in the purpose of the committee unless it is voted by 2/3 rd of the members present at a meeting commenced for the purpose and confirmed by 2/3rd of the members Present at the second special meeting.
26. BINDING UP : In case, the Society or Association has to be winged, the property and funds of the society/Association that will remain after full satisfaction of the Liabilities of the Society|Association will be transferred to be some other Institutions with similar aims and objects with approval of the 2/3rd majority of the General Body.
27. PROPERTY : Any management for the recovery of Property shall be enforceable against the Property of the association only and not against any individual member.
28. The Society/Association may use or to be used in the name of the President.
29. Functioning Hours: 10 A.M To 6 P.M.
30. GENERAL: All other provisions of the Societies Registration Act XXI of 1860, not specially mentioned here in shall also apply to the Association.
